In short the P4 certificate is an indicator of whether the contractor has the theoretical knowledge and possible experience to complete proposed solar PV projects whilst maintaining a high standard of design integrity, customer satisfaction and installation best practice.

Active Zone	Code (CN) 0 - 49%	No projects or activities have been logged for periods exceeding 12 months or activities have scored less than the required 50%. Risks associated with contractors in this range may be too high.
NV Zone (Not Visible)	Code (NV) 0 - 49%	This is the category for contractors who are known to have installed PV systems and who do not have an active presence in the PQRS platform, or; no PV projects or activities have been logged for periods exceeding 24 months.
